Arthur Goldberg, in article carried by SFChronicle, says flatly "There is no constitutional basis for President Nixon's refusal on the ground of executive privilege to make available the Watergate tapes subpoensed by Sen. Sam Ervin's committee and special prosecutor Archibald Cox. Simply put, Presidential tapes relating to criminal activities are not Goldberg cites four decisions, all decided last privileged" year - Brewster, Gravel, Branzburg, Caldwell - and says that the first two "involved a claim to privilege far stronger than the President's claim of executive privilege."
