Tapes - White House announces it will appeal/Sirica's ruling. "Aides" say other steps discussed ranged from asking Sirica to reconsider his decision, to appealing directly to the Supreme Court. They are ambiguous on the question of whether ~~it had been~~ consideration had been given to ignoring the ruling, which had seemed to be a possibility in WH's first reaction 29 Aug to ~~the~~ Sirica's decision, that "appellate review" was not the only way to "sustain the President's position." Immediately after the decision had been announced Wright and Buzhardt had "hurridely" flown to San Clemente to discuss it with Nixon, rather than wait for scheduled meeting with him on his return to Washington tomorrow.

(A) Police say they have recovered "from the youths" a tape recorder and cassette tape which had been erased and retaped with music. (Items stolen were five recordings, two recorders, portable radio, fifth of bourbon, folder with notes on Watergate.) WXPPost says the teenagers were caught "early Saturday," which would be 25 Aug; AP, in SFChronicle 31 Aug, says they were caught "early yesterday."

(B) Resolution would forbid Ervin committee to conduct any hearings or receive any testimony, except in executive session. Dole: "The people want the members of Congress to be concerned about the problems that affect them, and Watergate does not affect them."

Richard Danner, who delivered \$100,000 ~~to Rebozo~~ from Howard Hughes to Rebozo for Nixon, is questioned by ~~Ervin~~ ~~committee~~ Ervin committee investigators. Says he gave \$50,000 in \$100 bills to Rebozo at San Clemente, 3 Jul 70. In the case of the second \$50,000, also in cash, Danner had originally told the IRS that this was given to Rebozo at Key Biscayne in Aug 69, but tells Ervin committee investigators that he later gave the IRS an amended statement, suggesting it was possible the delivery could have occurred in a year later, in Aug 70.
