Ervin committee decides to delay resumption of hearings until 24 Sep because staff investigators had asked for an additional week to gather information; three investigators go to New Hampshire to interview potential witnesses, others are said to be checking records of Rebezzizzbank Key Biscayne Bank and Trust Co., operated by Rebozo. When hearings resume they will be limited to three days a week; committee hopes to complete investigation by 1 Nov. Ervin and Baker reject suggestions that the committee is responding to pressure from WH and Republican party leaders to terminate the hearings and turn the matter over to the courts.

Ervin and Baker say they remain determined to obtain access to the tapes, and Ervin describes them specifically as tapes "in an unaltered state."

Colson asks that his appearance before the committee be delayed because he is a target of a federal grand jury investigation, Dash is reported to have told the committee. Following this report, "sources" say, the committee decides it would be inappropriate to call Colson if he would refuse to answer questions.

The nature of the grand jury's investigation is not known, but speculation within the committee is that it involves the Fielding break-in. WXP has obtained a copy of a memo, dated 8 Aug, which says WX tax attorney George D. Webster "was involved in the \$5000 loan to Colson for the Ellsberg break-in." No further details.

Colson's lawyer confirms that Colson has testified before the newer grand jury (investigating Fielding case) for four to five days over the past two weeks.

Nixon has not held any worship services in the White House since 15 Apr 73, nor attended any public services since Easter [22 Apr] when in Key Biscayne when the Rev. John A. Executive privilege (milk price supports) - White House modifies its claims of executive privilege in suit brought by Public Citizen Inc. (Nader) and other consumer groups, which had asked for 67 White House memos concerning increase in milk price supports. In July White House had asserted executive privilege for all these documents, but today in affidavit filed with appellate court offers to release to the plaintiffs 7 documents, apparently without restriction, and to submitted private judicial review 24 others, including 5/which are censored. Censored segments of the six memos and the additional 36 memos will not be released.
