Jones (no date) Buzhardt says "it is believed that a tape recording was made"

At San Clemente press conference 22 Aug 73 Nixon said that when he took office he found "a taping capacity" in the White House and "had the entire system dismantled," and that "it was put into place in June of 1970." This was corrected same day by Warren, who said Nixon "misspoke" when he gave this date. One would be to file suit in U.S. District Court in WX or Baltimore to prevent Justice Department from continuing its investigation of Agnew, arguing that only Congress has authority to act while he is in office; the other would be for Agnew to ask the House of Representatives to conduct its own investigation and either clear him of charges or begin impeachment proceedings. Both are available to Agnew only as long as he is Vice President.

Post says Agnew discussed the possibility of resignation with Republican leaders in Colorado 16 Aug 73, the day after Nixon's speech, asking whether he should resign. Most of them advised him not to resign, and to fight the charges.
