Hunt was interviewed in 1969 by Colson, Magruder and Lyn Nofziger for (White House?) position involving public relations; was recommended by Magruder for that position but apparently not hired at that time.

The above is from **MEXEMPTX* a memo (paraphrase gives no further details) released by Ervin committee today, without explanation or elaboration. Committee also releases two other memos, one dated 28 Jul 71, Hunt to Colson, outlining plan to destroy Ellsberg's public image, and one dated 27 Aug 71, Ehrlichman to Colson, asking for "game plan" on how to use material obtained by Hunt and Liddy in their "proposed undertaking."

Tapes - Nixon lawyers ask U.S. District Court to reject the request for summary judgment by Ervin committee.
