Nixon/Agnew - Evans and Novak: "The seeming lack of any viable political policy inside the White House to deal with the swelling Agnew problem threatens a schism that may well harden anti-Nixon sentiment within the party's pro-Agnew right-wing. This is true despite Mr. Nixon's appeal late yesterday that the public give Agnew 'decent consideration and presumption of innocence,' an appeal that had a mocking echo from an apparent repeated administration effort the past few weeks to force him out."

Nixon/Howard Hughes. Jack Anderson says Ervin committee investigators are looking into two \$50,000 contributions to Nixon from Hughes, handed over in cash to Rebozo in 1969 and 1970, and described by Hughes aides as campaign contributions. Anderson points out that Nixon wasn't running for office in 1969 and 1970, and later in column says that in 1969 and 1970 Nixon was completing purchase of San Clemente estate. Says Ervin committee is investigating reports that the money "may have been diverted to the President's personal use."

Agnew's request that House of Representatives investigate the charges against him turned down today by Carl Albert in brief statement: "The Vice President's letter relates to matters before the courts. In viewof that fact, I, as Speaker, will not take any action on the letter at this time."

After Albert's announcement, Rep. John B. Anderson, of Ethingia House Republican conference, says he feels Albert, before making his decision, should have asked Richardson for information on whether the allegations against Agnew involve his conduct since taking office as Vice President. Later in the day he and Rep. William S. Cohen (R-Maine) introduce resolution calling on Speaker to appoint an appropriate committee to investigate whether these allegations involve activities in his tenure as Vice President. Most of the

Agnew/resignation - Asked by newsmen about Warren statement today that resignation had been discussed at meeting with Nixon yesterday, says, "I have not discussed that possibility. I want to make it very clear that I am not resigning."

Sen. Mark Hatfield, who invited Agnew to lunch today with 14 liberal to moderate Republican senators, says afterward that his very strong impression is that Agnew will not resign, that "there is no question this man is going to seek his rights." Says "angrily" that if Agnew "is another victim being cast aside by Machiavellan politicians around the White House" he will be more difficult to remove than some other officials have been; "This man is going to stand his ground and fight them."

(A) Ervin committee releases 34 political memos from Buchanan to Nixon, Haldeman and others. Sample; Buchanan to Nixon, "early 1971," saying Muskie was at that time the biggest threat, "and if Mr. Muskie is not cut and bleeding before he goes into New Hampshire, he will very likely do massively well there."

One of the memos deals with an effort to get Sigma Delta Chi to denounce 25 reporters, who met before a Nixon press conference in 1970 to discuss the questions they planned to ask; this is described in the memo as " setting strategy to embarrass the President."
