Agnew, speaking at convention of National Federation of Republican Women, Los Angeles (televised nationally), says he will not resign even if indicted; accuses unnamed Justice Department officials of trying to destroy him politically by "malicious and outrageous news leaks;" without naming him, singles out Petersen, saying that an examination of Petersen's record will show that - among other things - "he failed to get any of the information out about the true dimensions of the Watergate matter," and that through prosecution of Agnew Petersen hopes to "reinstate his reputation as a tough and courageous and hardnosed In WX, Richardson praises Petersen, says prosecutor." Agnew has" singled out for criticism a career public servant constrained from defending himself by the ethical standards governing a criminal investigation."

Agnew denounces as false reports that he has engaged with in plea bargaining with prosecution officials. Says that in April after he learned, "through the cocktail circuit and rumor mills of Washington" of threats by individuals (unnamed) to implicate him unless he used his office to cut off investigation of them, he sent them word that he would not help them, after which they obtained immunity from prosecution in an effort to escape "the full force of punishment by turning in someone higher up."

U.S. dictatorship? - "A special senate subcommittee [the year-old Special Committee on the Termination of the National Emergency, after a painstaking computer search of the statute books, concluded [today] the United States since 1933 has been operating under emergency rule, conferring near-authorization [authoritarian?] powers on its Presidents. Co-Chairmen Frank Church (D-Idaho), and Charles Mathias Jr., (R-Md.), said in a foreword to the 607-page [study] that only a few delegated powers have been regularly used, but added: 'It is possible that some future President could exercise this vast authority in an attempt to place the United States under authoritarian rule.
