Nixon/Cox/tapes - Tomorrow is the deadline for Nixon attorneys to file appeal from Appeals Court decision 12 Oct ordering Nixon to submit the tapes to Sirica.

Richardson has met twice this week (15, 16 Oct) with Cox in an apparent effort to negotiate a compromise which might avoid a Supreme Court showdown with Nixon on producing the tapes. Justice Department spokesman confirms that the meetings had taken place on those dates, but will not confirm or deny that was their purpose. Warren says Richardson has been "consulted" by Nixon attorneys, but declines repeatedly to say whether he has been authorized to find some compromise with Cox.

Abplanalp/ San Clemente - Cox releases letter to Bertram Podell (Dem-N.Y.), who had asked him to investigate if there had been illegal favoritism in government's 1971 decision to drop an antitrust investigation against Abplanalp, saying he had found "no evidence of improper conduct." Podell had suggested a connection between a loan from Abplanalp to Nixon to buy San Clemente property and the end of the antitrust inquiry into the Precision Valve Corp. (Justice Department began the investigation in Jun 69; Abplanalp made loan of \$450,000 on 11 Jul 69, made second loan of \$175,000 15 Jul 70, when first mortgage payment was due; in Feb 71 federal prosecutors in New York were told by their superiors in WX to "close out" the inquiry. For dates and amounts of loans, see Coopers and Lybrand audit, NYT 28 Aug 73, filed Nixon, real estate.)

Podell had asked Cox in July to look into the matter. He was indicted 12 Jul by federal grand jury in New York on bribery charges. Story does not say which came first,

Under the \$1.37-million evaluation the tax would be about \$13,500 annually; under the \$3-million evaluation the tax would be \$29,500.
