- Western Union says a record 71,000 telegrams have been received in its WX office in the first 36 hours after Cox's dismissal; 50,000 have been delivered to Capitol Hill, 6,000 to the White House; backlog of 15,000 still being processed. Reno office says telegrams to WX are running 150 per cent above normal. (SFC, 23 Oct.)

- European reaction: "Fred Emery, the Washington correspondent of the Times of London, wrote that as the FBI sealed off Cox's files 'the whiff of the Gestapo was in the clear October air. Grand juries - Sirica orders two Watergate grand juries to come to his courtroom tomorrow morning; spokesman says Sirica plans to read a short statement which will contain "general comments that the judge wants to make to the grand juries before they get back to work."

One of the grand juries is scheduled to resume hearing testimony tomorrow and will continue to be directed by members of the special prosecution force, although they now will be Justice Department employees.

(Haldeman was scheduled to testify before "two of the special prosecutor's grand juries" 22 Oct - entry 17 Oct.)

But I think one has to view that in some context . . . At the time that ... Richardson and ... Cox made representations to the Senate, presidential tapes were not an issue. Neither ... Richardson nor ... Cox knew there were such tapes."

Regarding tape summary in Nixon proposal, Wright says it would include exact words of conversations involving Watergate, except for possible deletion of "pungent" remarks; conversations on non-Watergate matters would be summarized.

In 1972, during the pre-April 7 campaign drive, Hughes gave \$50,000; story does not say whether by check or cash. "Just before the [1972] election, Mr. Nixon's solicitors returned to Mr. Hughes's agents and asked for more." Hughes gave another \$100,000, "qualified sources said." This donation was in the form of checks.

In this story the only mention of contribution in cash is the \$100,000 given Rebozo.

Nader announces he will file suit tomorrow, challenging Nixon's decision to fire Cox. Basis for the suit is explained by Al Morrison, who directs litigation for Public Citizen, Inc.:

"The lawsuit which we intend to file tomorrow challenges, first, the attempt to remove Special Prosecutor Cox from his position as the special prosecutor. The grounds for this First, that the regulation which creates the are two-fold. office of special prosecutor is still in effect, it has not yet been abolished, and it specifically provides, as Elliot Richardson stated before the Senate, that the person who holds that office may be discharged only 'for extraordinary improprieties on his part.' We contend that the rule of law requires a finding that there are no extraordinary improprieties, since the only act which is alleged to have been the basis for his firing is his continual insistence on litigating the claim of executive privilege, and the very same regulation specifically authorizes him to determine whether or not 'to contest the assertion of executive privilege.'

"The second ground which we are alleging is that the defendant in the lawsuit, who will be Robert Bork, the Acting Attorney General of the United States, is limited in his powers as Acting Attorney General, and that he may not, consistent with those limited, necessary powers, remove the Special Prosecutor, for that may be done only by a duly confirmed Attorney General of the United States, as Elliot Richardson was when he appointed Special Prosecutor Cox."
