Tapes, missing - At suddenly scheduled hearing in Sirica's court, Buzhardt says two of the subpoenaed tapes are non-existent because they never were recorded: that of Nixon-Dean meeting 15 Apr 73, and that of Nixon-Mitchell phone conversation 20 June 72.** See story, which among other things, includes the following:

- Warrenzielezzuewe Raymond C. Zumwalt, put on the stand by Buzhardt, "[testifies] that he had been told by his assistant, [James] Baker, on other occasions that the timer had malfunctioned in that manner." Special prosecutor Richard Ben-Veniste says Zumwalt had told him earlier in the day that he knew of no instances of recorder malfunction; Zumwalt says he became aware of this after a conversation today with Buzhardt.
- Cox, testifying before Senate Judiciary Committee, says he understands Nixon dictated a memo on the 15 Apr conversation into a tape recorder after the meeting, and that this tape should exist. (Why dictate a memo if Nixon at the time had every reason to believe the conversation was being taped?)
- Warren tells newsmen that while Nixon had listened to a number of the tapes he had never listened to all, and had never requested the two which are now missing. (See entry 10 Sep 73.)
- Warren says the tapes (how many?) had been (not now?) kept in a residential portion of the White House.

- Ervin tells reporters that he was assured by the White House as recently as 19 Oct that all nine tapes requested by the committee were complete.

Sen. William B. Saxbe confirms offer and acceptance of post as U.S. Attorney General. After a meeting with Nixon this morning, is reminded of his earlier expressions of doubt that Nixon knew nothing of the Watergate break-in, and asked if he feels now that Nixon didn't known about it. Says, "I satisfied myself that he really didn't."

Nixon bank records - WH acknowledges it is negotiating with Ervin committee on its efforts to gain access to records of Nixon's account in Rebozo's bank; committee sources say WH lawyers "had dug in their heels" and indicated they would claim executive privilege.

Impeachment, resignation - Howard K. Smith calls for Nixon's resignation or impeachment, in his commentary on ABC Evening News. "Either the Congress or the President, by his own patriotic decision, should relieve us of a burden too heavy to carry any longer." See entry 1 Nov, Ziegler.

Haig goes to Capitol Hill to reassure Republican leaders in the Senate that the tape of Nixon-Dean conversation 21 Mar 73 would prove that was the date Nixon first learned of the cover-up, and that the tape is "exculpatory."
