Tells Sirica she has been unable to prepare a full transcript of the tapes subpoenaed by the prosecutors.

Miss Woods' testimony raises another apparent discrepancy; says she was given eight tapes for the 28-29 Sep working weekend at Camp David; NYT says Bull had testified earlier in the week that 13 tapes had been taken there. **ENTITOR**

Miss Woods says that just before she left for court today Buzhardt found a tape covering the first part of the day of 16 Apr 73, which includes a meeting between Nixon and Dean.

Asked about Nixon's files, she says, "He's a saver. He saves menus from dinners - small things - and gives us those to file."

Tapes - There are defects in the seven tapes to be turned over to Sirica, according to WXPost, which bases its story on White House sources "questioned over the past three days." Portions of the tapes are "inaudible" due to "gaps in conversation, " "unevenness, " "excessive background noise, " cut-ins and cut-outs during conversation," and "periods of ("Gaps in conversation" and "periods of silence" silence." in voice-activated recording?) One source says microphones werezwightyxsensitivexsedxempmphexofzpikkingzup apparently failed to pick up some conversation; story points out that White House officials have said the microphones were highly sensitive and capable of picking up even hushed conversation, and quotes from testimony of Butterfield and Haldeman.

"Of five sources who confirmed that defects have been found in the tapes, one said the problems are 'of a suspicious nature.' According to this source, some conversation on some of the tapes appears to have been erased or obliterated by the injection — inadvertent or otherwise — of background noise." (Compare last sentence with that in same story as carried in SFC; if one or the other is a correction, there is no way of knowing which is the correct one.)
