Nixon meets with seven top Republican senators and representatives (Anderson, Scott, Griffin, Tower, Aiken, Ford, Rhodes), talks for nearly two hours about the effect of Watergate on his administration and ways to restore public conficence. Anderson predicts that information recorded on the tapes will be made public, after the tapes have been screened by Sirica and "the material" presented to the grand jury, but hints that this could be less than a full verbatim disclosure.* Anderson: "The President was absolute and complete in his assurance that he is going to cooperate with the courts and the special prosecutor. I feel a great deal more confident." * AMP D

Sentenced by Sirica, who says he is giving them the lowest minimum he thinks justified under the circumstances: A~~~~AHunt, two and a half to eight years, \$10,000 fine; McCord, one to five years; Sturgis, Martinez, Gonzalez, one to four years; Barker, 18 months to six years. All could have received sentences of from 50 to 65 years. Sturgis, Martinez and Gonzalez will be eligible for parole before Christmas. McCord and Liddy are appealing on the grounds they were convicted on perjured and incomplete testimony. (See McCord entry 30 Nov 73.)

Daniel E. Schultz, lawyer for the four Florida defencants, describes Sturgis as "that type of man representing the person who has historically made this country good." Asks, "How much more punishment do you mete out to the soldiers when the architects of the plan, the generals, haven't spent a day in jail and may never do so?"

Cox - U.S. District Judge Gerhard A. Gesell agrees to consider legality of Cox's dismissal and of the order temporarily abolishing the prosecution force. The dismissal was challenged 29 Oct 73 by Nader, later joined by Sen. Frank Moss and Reps. Bella Abzug and Jerome Waldie; Gesell drops Nader as a party in the suit, saying he has no legal standing to sue, and turns down requests for injunctions to "halt" the dismissal of Cox and Jaworski's acting as special prosecutor.

When Cox took the job in May he and Richardson worked out a set of guidelines (made an official departmental regulation when published 4 Jun 73 in Federal Register) which stated that he could be dismissed only for "extraordinary improprieties." This regulation was still in force when Cox was fired by Bork 20 Oct, "as instructed by the President," and with no mention of "extraordinary improprieties." On 23 Oct Bork issued a departmental order abolishing special prosecutor's office and turning its personnel and functions over to Criminal Division of Justice Department. On 1 Nov Jaworski was appointed and on 2 Nov

Bork ordered the old guidelines reinstated, with one change, that Jaworski could be dismissed only after Nixon contacts eight congressional leaders "ascertaining that their consensus is in accord with the proposed action."

Cox staff - WXPquotes unnamed member of staff as saying they are "pretty impressed by Jaworski's attitude," and Jaworski as saying "I'm happily impressed" and that he has heard nothing of any unwillingness of staff to stay on. WXP says many staff lawyers "are expressing in private conversation a sense of relief over Cox's replacement." (Relief/Cox was replaced? Relief that Jaworski was replacement?)

Special national election - Sen. William D. Hathaway (Dem-Maine) urges Congress to provide for a special national election if Nixon should leave office before Ford is sworn in. "If the President leaves office, the mandate of last year is negated. It seems logical to me to allow the people themselves to decide who shall then receive what only they can rightfully give." His proposal, and similar legislation suggested in the last few days by members of the House, is opposed by Mike Mansfield, who tells reporters Congress had "better follow constitutional procedures. This is no time for experimentation."

Richardson, in television interview, says a crisis of confidence exists and that "Several concerete steps have to be taken. The President has to find some way whereby some responsible group can ask him questions, but he doesn't have to be under oath."

Mixon-Wallace - Jack Anderson says Jaworski "has inherited a number of unfinished investigations that could embarrass the man who appointed him. ... There have been other awkward inquiries not mentioned in the press. The special prosecutors were questioning witnesses, for example, about a whispered deal between the President and Alabama's Governor George Wallace." See column, which says suggests that pressure was put on Wallace thereto run in 1972 campaign as a Democrat rather than as a third-party candidate, through tax investigation of Wallace's brother, Gerald, and of the Wallace brothers' law firm.

Impeachment - Joseph Alsop warns that "Fidel Castro and his Cubans" might attack Guantanamo Bay, the North Vietnamese are likely fairly soon "to tear up whatever remains of the truce agreement," and that "big Soviet air transports [are] revved up on the south Russian airfields where the Soviet airborne forces are now on alert."

"You may be ... in a righteous fever for President Nixon's impeachment. But you still have to include in your calculations the Watergate horror's hideous effect on the U.S. world position. All the foregoing threats are unquestionably Watergate-connected."
