Missing tapes - Undated round-up story,/includes the following:

"Haldeman ... was given 22 tapes on April 26, according to Secret Service records. Haldeman testified under oath he was sure he returned them the same day. But Secret Service records say that the 22 tapes were not turned in until ... six days later. As far as testimony in court is concerned, no one knows where those tapes were for those six days - and what might have been done with them. More importantly, three of the tapes that were missing for this six day period in April ... are among the most crucial tapes in the Watergate affair." Story does not describe these three, but one is that of Nixon-Dean conversation of 21 Mar 73.

"In July ... Haldeman was permitted to check out a total of nine tapes. One of those was for April 15 this year .... Oddly, there are no original Secret Service records to prove that Haldeman ever returned this tape. A Secret Service "log" notebook prepared in July, after the public learned of the existence of the White House recording system, lists \*\*zibat\*\*? What [sic - typo for "that"?] tape as having been returned. But the original records from which this notebook was prepared do not show that it was."

He's said it before, but this time, with his back up against the wall, Nixon and his associates\* have developed a new strategy to save his presidency. It's a strategy of negotiation - not confrontation, to borrow a favorite Nixon phrase from earlier, happier days. .... The latest in Nxion's many Watergate game plans may be, like its predecessors, too little and too late. .... The switch in tactics was apparently decided on last weekend at Key Biscayne. \*... The chastened behavior of the President and his men last week differed noticeably from their previous aggressiveness. .... They are promising to 'clarify' and 'explain' and 'cooperate' - as the price of survival'." See clipping.

Impeachment - Undated story says letters are being received by House Judiciary Committee at the rate of 5000 to 6000 a day and running better than 35 to 1 in favor of impeachment; daily flow ranges from low of 5,000 to as many as 17,000. Aide to the committee says most of the communications appear to be spontaneous and unsolicited, unlike the orchestrated letter campaigns on the busing issue and civil rights.

Charles Percy says (on Meet the Press) that to restore public confidence Nixon would have to make "total and complete disclosure [of] everything relating to the possibility of criminal activity. I think the President is preparing to do this now." Says this is shown by therefore "the very fact that we have now been invited, every member of Congress, every senator, every congressman, Democrat and Republican, to meet with the President next week in six unusual sessions" where Nixon will be questioned and explain his position.
