Nixon meets tonight with 15 Republican senators, whose comments indicate that the meeting answered relatively few specific questions, and that Nixon devoted himself to convincing them that he would explain his actions in full and soliciting their advice on when and how he should do this. Scott: "Everyong in the room - everyone - agreed on the need for full disclosure."

Sen. Pete V. Domenici of New Mexico says he pressed Nixon on reports earlier in the day about tape of conversation with Dean on 21 Mar; Republican congressional sources had quoted Haig as saying Nixon could be heard on the tape exclaiming, "Oh, my God!" when Dean told him of the coverup ("thereby buttressing [Nixon's] frequent assertions that he had not previously known of it" - NYT). Nixon reportedly confirms Haig's account.

Baker, leaving the meeting, indicates to reporters that questions had not be erased from his mind. "I don't really think we got that far into the factual situation."

Brooke says he repeated to Nixon his view that he should resign, and that Nixon replied that resignation "would be the easy way out and he was not going to take it."

James Buckley "gave the most upbeat account of the meeting ... but even he did not venture to suggest, as have some White House aides in recent days, that the meeting clear up all the doubts surrounding Mr. Nixon's role in Watergate and related activities."

Special prosecutor (and impeachment) - House Judiciary Committee approves bill creating a court-appointed special prosecutor (see entry 12 Nov), adding to it the requirement that the prosecutor "report at least monthly" to the committee chairman and ranking Republican member "such information [and, if requested, provide any "information, documents and other evidence"] as may be pertinent to the question of whether impeachable offenses have been committed."

LATimes: "The vote ... was a voice vote, with the chorus of 'ayes' coming mostly from the Democratic side and the 'nayes' from the Republican. If this voting pattern should continue when the measure comes before the full House, the bill would be approved but with less than the two-thirds majority needed to override the anticipated presidential veto."

In addition, Gulf also pleads guilty to having made smaller contributions to Rep. Wilbur D. Mills and Sen. Henry M. Jackson.

"According to Bennett's log, [following 1 Oct 73] the next movement of the controversial tape occurred on Nov. 13, \* when he took the tape to technicians of the National Security Agency to make copies. Bennett said the two copies were made in his presence, and that the original was never out of his sight. The original, Bennett said, was sealed in a box on Nov. 14 and on Nov. 26 was handed to Buzhardt for delivery to U.S. District Court. \*\*\*TETTEREFIEXT\*\* It was kept under guard in a safe in the court house until six U.S. marshals took it by train to New York for testing by the panel of court-appointed experts. The first copy, Bennett's log shows, was signed over to Buzhardt on Nov. 14. The second copy was kept in a White House safe until Nov. 29, when it was sent to Sirica, Bennett said."
