Nixon speaks at convention of Nat'l Assoc of Realtors in WX, in what is described by WXP as a "campaign-type review of the year's events, with only a minute devoted to charges of scandal." Frequent applause from sympathetic audience and "standing ovation when he defended his Watergate role." Blames "overzealous" associates for "mistakes that I never approved of, mistakes that I would never have tolerated, but mistakes for which I will have to take the responsibility."

Nixon meets with 78 House GOP members, who are impressed and relieved by "the candor, the obvious straight-forward honesty of his answers" (Rep. Dan Kuydendall, Tenn.).

Rep. Paul McCloskey: "I was impressed by his state of physical and emotional health," adding that there was "an air of unreality" about the meeting and that Nixon was not asked hard questions.

EXEMPLE:

Confused reporting by WXP (as carried in SFC) seems to say that today there is also a pre-dinner meeting with Republican senators and WH dinner for 50 to 60 moderate to conservative Democratic congressmen.

By tomorrow Nixon will have met with all 234 House and Senate Republicans. Some Democrats (unnamed) think these meetings with congressmen are a crude attempt to influence "his prospective grand jurors" in impeachment proceedings. SFC 16 Nov [WXP] Lou Gannon]

Nixon (fuel crisis) - Speed of presidential jet cut by 50 mph, reducing consumption from 2200 gallons of fuel per hour to 2000, no mention of reducing number of trips; back-up aircraft will not be used.

Jaworski - Deputy special Watergate prosecutor Henry Ruth, testifying before Senate Judiciary Committee, gives Jaworski unqualified endorsement. Calls for better guarantee against dismissal, saying he and other prosecutors want new legislation to accomplish this. Agrees with some committee Republicans that such a bill would be immediately tested in the courts, possibly resulting in indictments being thrown out if a law setting up a court-appointed prosecutor were found to be unconstitutional.

Krogh - Judge Gerhard A. Gesell, in WX, refuses to dismiss criminal charges against him, clearing the way for him to be tried on two counts of making false declarations, after Krogh's lawyers had argued (13 Nov?) that the charges should be thrown out because he was ordered to maintain the secrecy of the plumbers, even if it meant lying under oath.

Nixon's voting address is San Clemente and he is legally a California resident.

 Newspaper Guild's international board passes resolution asking Congress to initiate immediate impeachment proceedings against Nixon; union membership takes no action. SFC 16 Nov 73 [UPI, AP]

U.S.S.R. - Dr. Georgy Arbatov, described by Reuters as "the Kremlin's top expert on American affairs ... one of the brains behind the Soviet Union's new American policy," praises Nixon and Kissinger for "recognizing the realities" of the modern world. Reuters: "[This is] seen as indicating that despite Kremlin doubts about Mr. Nixon's future, Soviet leaders would like him to survive his current difficulties."

Nixon (Ervin committee) - At conclusion of today's hearings Weicker asks Ervin whether Nixon has responded to committee's request for a meeting; Ervin says there has been no response.

Ervin committee - Testimony by Russell DeYoung, of Goodyear Tire and Rubber, and George A. Spater, who retired from American Airlines shortly after he disclosed illegal contribution. Weicker asks Spater if it wasn't customary for corporate executives to be solicited for large contributions; Spater replies that the Nixon 1972 campaign was unique "because of the individual who made the solicitation [Kalmbach] and the amount involved [100,000 was requested, \$55,000 contributed]."

Gallup poll, taken 2-5 Nov 73 - Nixon's nine-week downtrend has leveled off at low point of 27 per cent approval, the same figure as that in previous poll (19-22 Oct); however, the figure for disapproval has risen, in the same period, from 60 to 63 per cent. Those polled were also asked to indicate how strongly they approve or disapprove of Nixon's handling of job as President; 15 per cent approve strongly, 44 per cent disapprove strongly.

Nixon (coup?) - Jack Anderson's column deals with contingency plans for the use of federal troops in case of a domestic crisis, drawn up to cope withriots and demonstrations in late 1960s. "Some high officials, aware of Mr. Nixon's belligerent attitude toward his Watergate critics, wonder whether he would use his emergency powers to hang on to the presidency if he should be faced with impeachment. Although the emergency plans are over four years old [sent to Nixon 19 May 69], they have been updated and reflect present policy."
