According to Rep. Charles W. Whalen Jr, who took notes at the meeting, Nixon said Cox was fired 20 Oct because (Whalen quoting Nixon) "Cox changed his mind on Friday night (October 19) because of lack of confidence in Senator Stennis. We did not know until Saturday he had changed his mind."

Cox, reached by phone, says he had "never questioned Senator Stennis's integrity at all." See story for Cox's chronology of letters sent to the White House, and time of their delivery, in which he stated his objections to the compromise plan. The earliest is a memo to Richardson 18 Oct, delivered at mid-afternoon. Story gives some of his objections, of the 11 he specified in memo to Richardson, and also objections expressed to Wright in letter delivered to WH by mid-morning.

Ehrlichman, Colson, Krogh - NYT, in undated story attributed to "informed sources," says that Buzhardt, beginning "in the summer," lobbied heavily with Richardson and Cox, arguing that federal indictments of Ehrlichman, Colson and Krogh should not be brought because prosecution would jeopardize national security. "'The president's position is that certain cases could not be brought and if they were, the prosecutors would have to be dropped, one source said. All the sources agreed that ... the activities in question include previously undisclosed domestic wiretapping and other physical surveillance. The sources said "ichardson's and Cox's unwillingness to take White House direction on these indictments helped precipitate the showdown that led to the resignation of Richardson and the firing of Cox on October 20."

"[Rep.] Charles W. Whalen Jr. (Rep-Ohio) quoted the President as saying Rebozo 'had the FBI check it out.'

Mr. Nixon said the FBI took fingerprints from the money and checked the serial numbers of the bills, according to Whalen. However, one FBI source said a check of the serial numbers would prove little unless there was a corresponding list of the numbers on bills Rebozo received."
