Dobrovir and three members of his public-interest law firm say that "ample evidence" has already been gathered to support a criminal indictment against Nixon for 28 "common crimes," and that "the House of Representatives could, today, impeach Richard Nixon for these same offenses," and that "The evidence against Richard Nixon is ample to satisfy the standard of proof required to hold a defendant to answer at trial to charges made against him."

Their 169-page study, released a day after the ACLU issued it own handbook for citizen action in its drive to bring Nixon to trial, was financed by Stewart R.Mott, described by WXP as a millionaire who has been working to bring about Nixon's impeachment.
