Tapes -. Buzhardt testifies at tape hearing that the official WH explanation of the 18-minute gap in tape of 20 Jun 72 (the explanation he had given the court 26 Nov) actually was "not a real certainty" but, instead, "just a possibility," and that when he had given his earlier explanation it was only as "a matter of belief." NYT: "The disclosure ... that the White House explanation was 'just a possibility' took many spectators by surprise for it had seemed clear that the White House meant to place on Miss Woods the full blame for the 18-minute gap."

Buzhardt, "after repeating the contention that the White House first learned of the full extent of the 18-minute gap on November 14,"*says he and others made a number of "tests" after that date, trying to duplicate on a tape the buzzing sound heard during the "gap." The most recent of the tests was made yesterday. "In one of his tests [Buzhardt] was able to duplicate the sound — and this duplication, he indicated, without explaining why [and without having "interrogated"her], apparently contributed to his 'belief' that Miss Woods did indeed cause the [entire?] gap."

Ben-Veniste introduces evidence to show that Miss Woods had in her possession nine WH recordings until 26 Nov, when at 8:30 a.m. she turned them in to Gen. Bennett, who is in charge of the tape library. NYT says the dates of the conversations covered in these recordings "all seem to coincide with the period of time when, [according to Dean's testimony,] the original Watergate defendants were demanding clemency."

- Miss Woods worked on tape of 20 Jun 72 while at Camp David, 28 and 29 Sep 73 (Entry 8 Nov). Worked on it again at WH 1 Oct, the day Bull brought her a high fidelity recorder (clipping, SFC/NYT 29 Nov). Did Bull, who testified he took a number of tapes to Camp David, also bring all of them back, returning this one of 20 Jun to Miss Woods when he delivered the recorder? Or was it in her possession 30 Sep (Sunday), a date which is not accounted for?

No indication Buzhardt has, or produced, test tape to prove this.

Nixon (finances) - Florida state attorney Richard Gerstein says he is investigating allegation that Nixon once had a \$100,000 certificate of deposit in Rebozo's Key Biscayne Bank; confirms story in Miami Herald that he has subpoenaed any records the bank has of Nixon's personal finances. Herald says subpoena was issued after Dade County prosecutor's office took testimony from former bank officers Richard Stearns and Franklin DeBoer, and that Stearns is believed to have told Gerstein's office of the certificate of interest.

Story by AP also tells of a \$10,000 campaign contribution deposited in the bank "days before" 7 Apr 72 deadline requiring disclosure of contributions, and says an attorney for Rebozo, William Frates, told the Herald the account was opened for a single contribution from an unidentified donor.

Milk fund - Justice Department says Nixon has waived executive privilege for documents on milk industry contributions (no date), and that it has turned these over to Jaworski. Justice Department official refuses to describe these, saying WH still claims executive privilege over them in other litigation, but does say the material does not include tape recordings.

NYT says it has been reported recently (no date) that a representative of one of the co-ops, AMPI, in Aug 69, delivered \$100,000 to Kalmbach.

Buzhardt - Ziegler (described by NYT as having "emerged in recent weeks as one of [Nixon's] closest advisers"), at press briefing appears to indicate "a decline in the status of ... Buzhardt. Asked whether the President was dissatisfied with Buzhardt's work, Ziegler replied obliquely, remarking that he did not want to express 'dissatisfaction with the performance of any individual. ... But Ziegler said the White House staff legal staff has been carrying a very heavy work load that led 'to some mistakes.' He mentioned as an example the staff's failure to discover until November 14 exactly which Watergate tapes had been subpoenaed earlier." (Cont'd)

Buzhardt tells newsmen later that "I have no plans to resign" and says that as far as he knows he still is WH counsel in charge of Watergate legal matters.

NYT says Ziegler's veiled remarks appear to add up to a demotion for Buzhardt, that other WH sources say control of the case is expected to pass in the next few days to Judge John J. Sullivan of Illinois appellate court, who is already working at EOB. Sullivan is a Democrat who has known Nixon since his Navy days.

Special prosecutor's staff is bitterly attacked by Ziegler at news briefing (preceding entry). Ziegler says
Jaworski is "a very respected man, a very fair man," but says the staff has displayed an "ingrained suspicion and visceral dislike for this President and this administration."
