Rose Mary Woods is "awfully upset" about the way WH lawyers have been handling the case of the 18-minute gap in the tape, and the way they have been portraying her role in creating the gap, according to her lawyer, Charles Rhyne, who "made it clear that he is upset as well, and that he feels that the White House lawyers have behaved improperly in their dealings with hiss Woods." MYT says current edition of Newsweek quotes Rhyne as telling a friend that WH lawyers were throwing her to the wolves.* This is denied tonight by Rhyne in telephone interview, saying he does not know "where Newsweek got those quotes" since he has not spoken to anyone from the magazine or discussed the case with any of his friends.

"As Rhyne ... sees it, the White House lawyers present in court that day were, in effect, Miss Woods' lawyers. And as her lawyers, he said [tonight], they had a duty to correct the record and remove any 'ambiguity.' 'One of the things you're supposed to do is not let the record look bad for your client,' he said."

Harris poll, conducted for Senate Subcommittee on Intergovernmental Relations and released by the subcommittee today, shows that a majority of those polled, 53 per cent, agree that "there is something deeply wrong in America;" 37 per cent disagree. Harris organization says it is the first time since the assassinations of King and Robert Kennedy in 1968 that a majority has answered the question in the affirmative. When those polled were asked "what they would bring up if they had a chance to sit down and talk with President Nixon, three out of every four persons said 'Watergate.'"

"Impeachment Possible in January." "Some congressional Republicans acknowledge that President Nixon is operating against a late-January deadline in his campaign to lift the Watergate cloud from his administration. If he fails by the time the next session of Congress begins, about Jan. 21, a serious impeachment move could come, they say. ... [One] Republican, quoted by his aide, said visits home during the recess could result in a 'changed attitude' toward Nixon among many House Republicans who have so far balked at impeachment."

" Post does not say Colson intervened, but Gagliardi was not indicted and the case was dropped. UPI points out that after Colson left the WH and entered private law practice one of his first climets was the Teamsters Union.
