This appears to be the Joint Contressional Committee on Internal Revenue Taxation, headed by Rep. Wilbur Mills. Statement by Nixon says, "I will abide by the committee's judgment."

Reporters are permitted to inspect copies of Nixo, 's tax returns for 1969-72, but copies may not be taken out of the

White House, nor may they be photographed.
