Tapes (18-minute buzz) - Sirica, from the bench, reads a news release on the "preliminary result" of study of the tape by panel of experts, says thickfinding their finding was that neither the high-intensity lamp nor the electric typewriter was the "likely" cause of the buzzing sound. Sirica says there are "some indications" that the Uher tape recorder "could have" caused the buzz, and that there are also "indications" that any voices which might have been on the tape appear lost beyond retrieval; both are "yet to be confirmed by further study." Says a full report on the 20 Jun tape is expected after the end of the year.

For the first time Sirica lists the specific questions

Nixon (secret portfolio) - Jack Anderson says special prosecutor's office "has turned up" a set of secret tapes in which Franklin Deboer, for a time vice president in charge of the trust department of Rebozo's bank, boasts that he handled a secret portfolio for Nixon at that bank. Apparently, from transcript as given by Anderson, Deboer handled similar portfolios for Rebozo and Abplanalp.

"A source close to Rebozo declared firmly that 'Deboer never handled any portfolio for any of the three individuals outside or inside the bank." Deboer's statement is denounced as completely false by a WH spokesman, who says Nixon's detailed financial statement completely refutes it.

Vesco's company chartered a helicopter for use by former WH aide Harry S. Dent in his campaign appearances for Nixon in New Jersey last year, "according to records collected for a federal investigation." Story says other prominent figures, "including apparently a brother and nephew of Nixon" also used the helicopter.

"Despite an assertion by Harry L. Sears, former chairman of the presidential re-election campaign in New Jersey, that his committee paid[for the helicopter], helicopter records show that the International Controls Corp, then headed by Vesco, paid for the charter. Corporations are barred by law from contributing money or services to political campaigns."
