Presidential power - Twenty participants, after a week-long constitutional conference, propose the creation by constitutional amendment of the office of an independent "counselor general," to curb abuses of presidential power. Professor Paul Mishkin (University of California at Berkeley) says the presence of an officer to receive complaints about the president would reassure the public and civil servants "who want to resist but feel they have nowhere to go."

The participants are scholars and former government advisers. Conference was held at the Center for the Study of Democratic Institutions, Santa Barbara, and was called at the request of the Ervin committee. No date is given for the conference.
