AP says "The President had tentatively planned to go to his Key Biscayne family home before Christmas but apparently decided he could not make that trip without using government aircraft."

Gray - "A confidential FBI report apparently contradicts the testimony of L. Patrick Gray III last March that he had no knowledge of nearly 20 'national security' wiretaps that President Nixon had ordered on newsmen and officials of his administration. ... However, a copy of the confidential FBI report, obtained by the New York Times, indicates that Gray, while the bureau's acting director, had been advised in advance of his testimony of the by-then defunct surveillance operation."

Gurney, "President Nixon's loyal ally on [the Ervin committee], has ceased to be an active, functioning member ..., according to Senate sources and records. A check shows that Gurney has not been present at the committee's last eight public sessions [31 Oct to 15 Nov] ... during which period Gurney acknowledged that the Justice Department was investigating allegations that Florida builders secretly contributed large sums of money to him " *

IRS - "An Internal Revenue Service official [Roger V. Barth, resigning 31 Dec] said [last week] that he has kept President Nixon advised of any tax problems involving his friends and associates that could embarrass the White House [and that] he thinks the practice of informing the White House about 'sensitive cases' is a 'good idea.' And that it goes back at least to 1963." Barth was advance man for Nixon daughters during 1968 campaign; joined IRS in 1969 as assistant to the commissioner; in Nov 72 went to chief counsel's office.
