Tapes, transcripts and summaries - "The White House adknowledged [today] that President Nixon has changed his mind about making summaries of key Watergate-related tapes available to the public. ... Warren said Mr. Nixon's previously announced decision to Republican officeholders that summaries of the tapes would be made public is being 're-evaluated,' ... [Taying] heavy emphasis on events that have occurred since Mr. Nixon's promise to make the tape summaries public. Among these, Warren said, was the 'indiscretion' committed by attorney William Dobrovir when he played portions of a tape in his custody at a Georgetown cocktail party and the demand for many additional tapes and documents by the Senate Watergate committee."

- ITT/milk fund - Laird and Warren say reports on WH role in ITT and milk fund cases will be made public as promised by Nixon; will producty be released in mid-January after he has previewed them with Republican congressional officials.

Tapes, subpoena by Ervin committee - U.S. Court of Appeals grants committee's request for new hearing on its original request and orders Sirica to hold the new hearing.

Haldeman, Ehrlichman - WH denies it is giving copies of Haldeman and Ehrlichman's files to Wilson; Wilson denies he has an arrangement with WH to receive copies of his clients' material turned over to special prosecutor; Buzhardt says the three have received no special preferential treatment from him in the matter, but concedes that others at the WH "may have" provided Haldeman and Ehrlichman privileged treatment.

Nixon "gift" papers - Tax Reform Research Group (Nader) files FOA suit for access to Nixon vice presidential papers, claiming that restrictions placed on them by Nixon are invalid; says most of the papers already were government property before he donated them, and the deed for the second "gift" was not legally executed.

"The suit may prove important ... because it takes key issues ... into court. Mr. Nixon has asked a joint congressional committee to study the tax situation surrounding the gift of papers but no other legal action is pending." SFC 29 Dec 73 [AP]

Resignation - Waldie predicts that Nixon will resign before the end of March because Republicans will begin demanding it after sounding out their constituents, to avoid disaster in the 1974 elections.
