Nixon (California taxes) - William M. Bennett, member of State Board of Equalization, files complaint with State Franchise Tax Board, formally requesting the tax board to bill Nixon for state income taxes. Complaint says Nixon has voted in California since 1969, owns property, and has a personal attorney, accountant, physician and a bank account in California; that whenever there is a question about a person's tax liability, the state sends the individual an assessment of estimated taxes, which is then paid under protest pending appeal.

Ford says Nixon, during two-hour meeting with him 21 Jan, volunteered to show him information proving he had no prior knowledge of Watergate break-in or subsequent efforts at cover-up. When asked if his knowledge was connected with statement by Scott 20 Jan in which he said he had information which would clear Nixon in some aspects of the case, Frod says he has not seen those transcripts.

Impeachment - Rodino says impeachment inquiry might have to be extended for a year beyond the April target date if Jaworski's office does not turn over relevant grand jury evidence to the committee, because the panel would have to duplicate that investigation.

Ziegler, in first press briefing in more than a month, says of Nixon's drop in polls that some of it is caused by Watergate break-in and subsequent cover-up. "But the substantial impact has been the constant, constant, constant, constant charge, charge, charge against the President of the United States - unsupported charges, but charges very difficult to catch up with before they become implanted in public opinion." Says Nixon will not resign (is "not entertaining at all" suggestions that he do so); that WH intends to forego further counter-attacks against Watergate critics and concentrate instead on running the government.
