WH officials say that Nixon will not be charged for any portion of flight to California 9 Aug 74. "Officials [unnamed] denied today there had been any plan to charge Mr. Nixon and said that President Ford had instead directed the Defense Department, which operates the aircraft, to pick up all of the costs of the flight."

There is no indication in story whether Ford's order was given before or after complaint by Ziegler in intv published yesterday.

Nixon (San Clemente ^{mortgage}/paid off) - Charles Horning, attorney for the Cotton Estate, says he has been informed by Nixon's personal attorney, Dean S. Butler, that a certified check will arrive in his office tomorrow; check will be for \$506,000 plus about \$17,000 in interest and is the final payment on the Nixon mortgage which expires this week following a six-month extension.

Horning says he is not certain how much of the payment will actually come from Nixon; he (LATimes:) "indicates" that Nixon's signature will not be on the check. Part of the payment will be the obligation of B & C Investment Co., formed by Abplanalp and Rebozo, which purchased roughly 23 of the 28.9 acres of the estate from Nixon in 1970 for a reported ^{price} \$1,249,000. "Last year" a WH statement said Nixon's share ^B of this last payment would be \$226,440.

Abplanalp said 8 Dec 74 he, Rebozo and others were considering forming a nonprofit foundation to help pay for Nixon's mortgages, including that for San Clemente. ^A See ^A entry 8 Dec 74, Nixon properties. See entry 9 Jan 75,
