NEW HAVEN, Aug. 7—The Federal Bureau of Investigation said today that it was conducting a "preliminary" investigation of financial aspects of Senator George McGovern's 197

Democratic presidential campaign here at the specific request of Archibald Cox the special Watergate proscutor.

Herbert Clough, special agent in charge of the New Haven office of the F.B.I, said that agents were reviewing contribution and spending records filed by McGovern campaign groups with the Secretary of State in Hartford and that persons involved in the unsuccessful campaign would be interviewed this week.

"We are conducting a preliminary and limited investigation at the specific request of Special Prosecutor Archibald Cox into an allegation brought to his attention by a private citizen," Mr. Clough said. He declined to explain details of the allegation.

John Brker, a spokesman in Washington for the Watergate prosecutor, said that he could neither confirm nor deny the F.B.I. report.

The investigation came to light today when Mrs. Gloria Schaffer, the Secretary of State and a McGovern supporter in 1972, confirmed reports today in Hartford that the F.B.I. had asked to see the records at the request of Mr. Cox.

"There is such excitement over this F.B.I. guy in the files," Mrs. Schaffer said. "The story is very simply that an F.B.I. man called yesterday and said he would like to come over and look at the 1972 Democratic campaign file."

"I didn't ask him whether he was interested in anything specific—I didn't think it was my place," she said.

sistant to Mrs. Schaffer, said:
"The F.B.I. told us to shut up about this. I think they want to keep a lid on where the information is coming from. They're naturally very secretive people."

Included in the records, which are open to the public, are forms filed by state and local McGovern-for-President groups and copies of forms filed with the Federal Government.

There were no reports of similar investigations in New York and New Jersey, where the only forms on file are copies of the reports sent to the Federal Government in Washington. Washington.

"I'm just completely floored," the Westport lawyer said "We had no inkling that anything was going on at all. We have gone through a thorough audit and we're closing out our books and I know of no irregularities that have been
