## Refunds to Holders Asked Of Steinbrenner by S.E.C.

WASHINGTON, April 15—
The Securities and Exchange Commission charged the American Ship Building Company today with making illegal political contributions and asked a Federal court here to require George M. Steinbrenner 3d, its chairman, to reimburse stockholders by more than \$120,000.

It was the second Federal citation this month against Mr.

citation this month against Mr. Steinbrenner, who is also the principal partner in the New York Yankees, and against American Ship Building for alleged political contributions. On April 5 in acceptance of the principal steps of t leged political contributions. On April 5, in an action signed by the special prosecutor, Leon Jaworski, a Federal grand jury in Cleveland indicted Mr. Steinbrenner on 14 felony charges in connection with contributions to Republicans and Democrats.

The commission's complaint charged the company and Mr. Steinbrenner with attempting to disguise the illegal contributions to the Finance Committee to Re-elect the President and to other "political campaigns" as ordinary business expenses. Company employes testified during the commission's investigation that they had been paid "bonuses" and instructed to whom the money should be paid as contributions.
