Officials close to the inquiry said today that, when the committee holds a business meeting next Thursday or Friday, Mr. Rodino plans to recommend the publication of the Watergate evidence. They said that the disclosure might take some time, however, so that the sources of confidential evidence, particularly the special prosecutor and the senate Watergate committee, could be consulted. Before disclosing such evidence, the committee must vote either to amend or to breach its formal rules assuring the confidentiality of the evidence. Mr. Conyers has been among the most ardent advocates of full disclosure of the material. He said, in that connection, that the Internal Revenue Service had "stonewalled" the committee.
