MASQUERADING EVENHAND JUSTICE **Him Without Sin Cast The First St**

American practices and procedures concerning our Grand Jury system of indictment leading to a trial jury are part and parcel of the Constitution.

The Democratic and Republican signers of this statement were shocked by a Grand Jury naming the President of the United States as an unindicted co-conspirator in the Watergate fiasco. THAT WASHINGTON GRAND JURY WAS SELECTED FROM THE CITY WHICH IN 1972 VOTED 78% AGAINST MR. NIXON. Could a more blatantly prejudiced and unfair Grand Jury be found anywhere in the United States? This grave injustice has been aggravated by a large part of the media who have been and still are obviously seeking to get rid of President Nixon by fair means or foul. For example, the June 17th Newsweek devoted an entire page in headlines to such a deceptive assertion as: "THE JURY NAMES NIXON." Have you fellow citizens seen any rebuttals in your newspapers, magazines or on TV. Or have you read or heard the facts about the Washington Grand Jury? Probably not. As Claire Luce said: "What sickens me is the hypocrisy of it all. The press itself is a gigantic bugging machine which has invaded everyone's privacy." The media investigators, prosecutors and some members of Congress, are ignoring truth, decency and omitting the fact that President Nixon has not been proven guilty of bribery or treason, or any other high crimes and misdemeanor. Furthermore, the unjust and underhanded attacks on the President are propa-

gated through a cascade of leaks and improper statements.

Every fair-minded lawyer knows that no member of the Grand Jury had the knowledge, capacity or time to write out a long list of criminal charges against the President. It was the work of one of more biased prosecutors probably with the knowledge and consent of the chief prosecutor in obtaining the signatures of 19 overwhelmingly, if not totally, anti-Nixon Grand Jurors. It was a travesty of justice obviously to poison the minds of the American people. Fair-minded Americans believe in a fair trial and justice for all. for McGovern?

Is not Ehrlichman and his lawyers justified in asking for a new trial on account of the alleged prejudice of the jurors and the security of the nation. This is the main reason for the existence of all governments. No judge should refuse a change of venue in view of the demonstrated partisanship and prejudice to say

nothing of the questioned impartiality of some of the jurors.

Justice must be evenhanded in the interest of all of the American people and of the United States or it is not justice. It then becomes as in this case, a partisan propaganda trick to smear and destroy the presidency and our three separate and coordinate branches of government. Has the flame of liberty burned so low that the Grand Jury has become a puppet for the prosecutors? Abraham Lincoln said: "Neither let us be slandered from our duty by false accusations against us, nor be frightened from it by menaces of destruction or our government, nor dungeons to our-
