Richard M. Nixon was examined by court-appointed doctors at his estate here today to get an opinion on whether his health would be endangered by testifying at the Watergate cover-up trial. Three doctors named by United States District Judge John J. Sirica drove here from Long Beach, Calif., in a United States marshal's car after spending the morning going over Mr. Nixon's written records at Long Beach Memorial Hospital.

The head of the panel, Dr. Charles A. Hufnagel refused to answer any questions from newsmen about the doctors' preliminary findings. They are under orders to report back to Judge Sirica by Friday. 29

Possible Transfer of Trial

Judge Sirica had indicated that, depending upon their findings, he might transfer the Watergate trial to San Clemente temporarily to hear Mr. Nixon's testimony testimony

In addition to Dr. Hufnagel, In addition to Dr. Hufnagel, a cardiovascular specialist associated with Georgetown University Hospital in Washington, the panel members are Dr. John A. Spitell Jr., an internist with the Mayo Clinic in Rochester, Minn., and Dr. Richard Starr Ross, a cardiovascular disease specialist at the Johns Hopkins University Hospital and Medical School in Baltimore.

The visiting doctors were accompanied to San Clemente by Dr. Eldon B. Hickman, the surgeon who performed the operation on Mr. Nixon on Oct. 29 to prevent the movement of blood clts, caused by a phlebitis condition, from his left leg to his heart and lungs.

Lungren, Mr. Nixon's personal physician, both have reported previously that Mr. Nixon came close to death in a relapse following the surgery and should not be submitted to stress for up to three months.

Dr. Hufnagel spent more than three hours going over Mr. Nixon's records at the hospital.

No Details on Exam

Dr. Hufnagel refused to give any indication of the type of examination the doctors had given Mr. Nixon at his home: Whether they simply talked with him, or conducted medical

Dr. Hufnagel said after arrival in Long Beach yesterday that the doctors would not call on Mr. Nixon if his medical records showed the stress of an examination would endanger him.
