VICE PRESIDENT CALVIN COOLIDGE HAD A LITTLE TROUBLE OVER THE OATH,

THE WORD OF PRESIDENT WARREN G. HARDING'S DEATH REACHED COOLIDGE AT HIS HOME IN PLYMOUTH, VI., IN THE MIDDLE OF THE NIGHT, ON AUG. 2, 1923.

IT CAUGHT THE VICE PRESIDENT BY SURPRISE.

IN HIS AUTOBIOGRAPHY, COOLIDGE SAID HE ASKED HIS FATHER, JOHN CALVIN COOLIDGE, IF HE STILL HELD THE POSITION OF NOTARY PUBLIC. RECEIVING AN AFFIRMATIVE ANSWER, THE VICE PRESIDENT SAID TO HIS FATHER, "THEN, I WANT YOU TO SWEAR ME IN."

"I DO SOLEMNLY SWEAR (OR AFFIRM) THAT I WILL FAITHFULLY EXECUTE THE OFFICE OF PRESIDENT OF THE UNITED STATES, AND WILL, TO THE BEST OF MY ABILITY, PRESERVE, PROTECT, AND DEFEND THE CONSTITUTION OF THE UNITED STATES."
