Girl Dies; He Faces Arrest

EDGARTOWN, M a rtha's Vineyard (Mass.) -A car driven by Sen. Edward Kennedy plunged off a narrow wooden bridge early yesterday, killing a pretty blonde secretary riding with him.

The accident went unreported for about eight hours. 



midnight and 1 a.m. yesterday, and Kennedy did not report it until 9 a.m., half an hour after two young fishermen reported finding the car.

Arena said he believed the mishap was "strictly accidental" and there was "no sign of negligence, speed, things like that."

Arena himself tried to find the body after the car was found but before Kennedy reported it. Arena said the current was so strong there that he had to give up and call on scuba divers who made the grim find.

Kennedy was unharmed but said he was in a state of shock for several hours before reporting the accident to

"I have no recollection of how I got out of the car,"

Kennedy said.

A medical examiner ruled Miss Kopechne drowned.

The bridge is an isolated area approached by a narrow dirt road. Kennedy gave police this written statement regarding the accident:

The car turned over and sank in the water and landed with the roof resting on the bottom. I attempted to open the door and window of the car but I have no recollection of how I got out of the car.

'Dove Down'

"I came to the surface and repeatedly dove down to see if the passenger was still in it. I was unsuccessful in the attempt.

"I was exhausted and in state of shock and I recall that I was able to get back to some friends who had a car press.

parked in front of a cottage. asked someone to bring me back to Edgartown.

"I remember walking around for a period of time and when I suddenly realized what happened I immediately called the police."

Kennedy went to Edgartown for the Edgartown Yacht Club regatta Friday and sailed the family yacht, Ventura, to a ninth-place finish.

Kennedy's press secretary, Richard Drayne, said that Friday night he went by car ferry to Chappaquiddick Island to drop in on a gathering of former Robert Kennedy campaign workers to thank them. Among them was Miss Kopechne.

He told police he offered her a ride in his car to the island ferry landing for the trip back to Edgartown when the accident happened.

Arena said that Kennedy requested that his statement not be released until he had time to review it with counsel.

The chief said that he went ahead and released it at 3 p.m. although he had not heard from the senator be-cause of "pressure" from the

The chief said he did not Chappaquiddick Island yes-know who took the senator terday morning. back to his hotel, the Shiretown Inn, in Edgartown or how they got there. The po-lice chief said he did not get the names of the friends.

The last ferry between Chappaquiddick Island and the Vineyard leaves at 1 a.m. Ferry officials said Kennedy was not on it and that he was not on it the last few previous trips.

A ferry worker claimed that Kennedy took the ferry from the Vineyard back to

He said that the senator went into a small building near the ferry landing and stayed for some time, then took the ferry back to the Vineyard. The worker said that the building contains a telephone.

Mrs. Joseph Kopechne of Berkeley Heights, N.J., mother of the victim, said, that as far as her daughter was con-cerned, "the Kennedys could do no wrong.

The medical examiner said that he saw Miss Kopechne's


body about 9:30 a.m. The woman was clothed in a white blouse and slacks. She was found in the back seat of the car, police said.

A spokesman in Kennedy's office said the senator's wife, Joan, and their children have been at the Kennedy home on Squaw Island, near Hyannis Port, for the past several days.

It was the second time Kennedy was nearly killed. He suffered a broken back in a plane crash five years ago. All three of his older brothers met violent death.
