# **Noguchi Gets** His Job Back

Los Angeles

Dr. Thomas Noguchi was reinstated yesterday to the post of county coroner, the job he was fired from five months ago amid charges he needed psychiatric care. a settlement.

The Civil Service Commission overruled county supervisors who dropped the pathologist from his 104-a-year post last March

Noguchi said at the end of the hearing he was confident he would get his job back.

The commission heard 21 days of testimony on 60 specific charges against the coronor, five of which were dismissed for lack of evidence. The accusations were some of the most bizarre ever lodged against a public official.

Detailed in a 10-page petter prepared by Lindon S Hollinger, the county administrative officer, they included reprts that Noguchi prayed for airplane crashes that would bring glory to the coroner's office and expressed a desire to perform autopsies on county officials, incluing Hollinger, who were still alive.

Deputy county counsel Martin Weekes charged that as Caper F. Kennedy fought for his life at Good Samari-

tan Hospital, Noguchi danced in his office in glee and said:

"I am going to be famous. I hope he dies. Because if he dies, then my international reputation will be established.

Isacc blamed many of the allegations on people outside the coroner's office misunderstanding the "graveyard humor" within. He denied all the charges "generally and specifically" and summoned character witnesses to testify on behalf of Noguchi.

LOS ANGELES, July 31 (UPI)

Dr. Thomas T. Noguchi, who supervised the autopsy of Senator Robert F. Kennedy, was ordered reinstated today as county coroner, the job from which he was dismissed five months ago.

Visors, who dismissed Dr. Noguchi March 18, and ordered the Japanese-born pathologist restored to his \$31,104-a-year job with back pay for the last five months.
