BUFFALO, N.Y., FEB.26 (AP)-A HOTEL OWNER WAS ORDERED TODAY TO SHOW WHY HE SHOULD NOT GRANT USE OF A HOTEL ROOM FOR A TALK BY A LAWYER HIRED BY LEE HARVEY OSWALD'S MOTHER.

THE LAWYER, MARK LANE, CLAIMS THERE IS NO FIRM EVIDENCE THAT OSWALD, ACCUSED SLAYER OF PRESIDENT KENNEDY, SHOT THE PRESIDENT.

LANE WAS TO SPEAK FRIDAY NIGHT IN A ROOM AT THE HOTEL BUFFALO ABOUT THE ASSASSINATION.

JUSTICE MATTHEW J. JASEN OF STATE SUPREME COURT INSTRUCTED JOSEPH RADNER, OWNER OF THE HOTEL, TO APPEAR BEFORE HIM EARLIER FRIDAY. JASEN'S ORDER CAME ON AN ACTION BROUGHT BY THE COMMITTEE TO HEAR MARK LANE (CAP C H M L)

MRS. MARYANN WEISSMAN, A COMMITTEE MEMBER, SAID SHE HAD MADE A \$15 DEPOSIT FOR THE ROOM FOR LANE'S TALK AND CONFIRMED ARRANGEMENTS TWO DAYS LATER.

SHE SAID THAT AFTER PUBLICITY WAS GIVEN TO THE SCHEDULED TALK, PATRICK J. CARROLL, EXECUTIVE ASSISTANT MANAGER OF THE HOTEL, NOTIFIED HER THAT THE ROOM WOULD NOT BE AVAILABLE.

SHE SAID CARROLL ASSERTED HE HAD NOT REALIZED AT THE TIME THE COMMITTEE RENTED THE ROOM THAT ANOTHER ORGANIZATION HAD RENTED IT EARLIER FOR THE SAME TIME.

THE COMMITTEE CONTENDS THAT THE OTHER BODY, THE COMMITTEE FOR THE PRESERVATION OF FAMILY LIFE, HAD NO ARRANGEMENTS TO RENT THE ROOM.

MRS. WEISSMAN SAID SHE ASKED IF OTHER ACCOMMODATIONS WERE AVAILABLE AND WAS TOLD NONE WERE.

THE COMMITTEE TO HEAR MARK LANE IS COMPOSED OF STUDENTS AT THE STATE UNIVERSITY OF NEW YORK AT BUFFALO AND THE STATE UNIVERSITY COLLEGE AT BUFFALO.

LANE, A FORMER NEW YORK STATE ASSEMBLYMAN, WAS RETAINED BY MRS. MARGUERITE OSWALD TO BRING THE OSWALD CASE BEFORE THE WARREN COMMISSION, WHICH IS INVESTIGATING KENNEDY'S DEATH.
