MRS. GRANT, ONE OF TWO SISTERS OF THE MAN WHO SLEW LEE HARVEY OSWALD, DECLINED COMMENT ABOUT RUBY'S ESTATE.

RUBY DIED LAST MONTH OF CANCER. HE KILLED OSWALD, IDENTIFIED BY THE WARREN COMMISSION AS PRESIDENT KENNEDY'S ASSASSIN, NOV. 24, 1963.

ONE WILL, LOST FOR 16 YEARS BEFORE A DALLAS LAWYER FOUND IT IN HIS GARAGE, WOULD GIVE ONE-FOURTH OF RUBY'S ESTATE TO MRS. GRANT. ANOTHER, FILED BY A FORMER DEPUTY SHERIFF, LEAVES A WATCH, A RING AND A SUIT TO LAWMAN NORMAN H. HOOTEN. HOOTEN GUARDED RUBY FOR A TIME IN DALLAS COUNTY JAIL.
