Loran Eugene Hall

- 29 Dec 67 Subpena issued for his appearance before Orleans Parish grand jury 1 and 2 Feb 68.
- Says charges against him are

 "absolutely false." Will force
 Garrison to extradite him but then
 would go "because I think it's time
 the American people found out the
 whole truth about the Kennedy
 assassination." Denies knowing
 "anyone .. involved in the
 assassination or anyone ever
 mentioned by Garrison or anybody
 else." Edgar Eugene Bradley was
 charged by Garrison with conspiracy
 20 Dec 67.
- 31 Dec 67 At party "someone hit my right arm with a needle." Later develops serum hepatitis which he attributes to this incident. [Eberle, LA Free Press 24 May 68.]
- 2 Jan 68 Says he has been receiving harassing phone calls. (From Bradley? See item dated 24 May 68, below.)
- 24 Jan 68 Superior Court, Bakersfield, quashes Garrison subpena. Hall appears in court with skin yellowed by jaundice (hepatitis?).
 - North Valley Mail carries item linking Hall and Bradley.

16 Mar 68 - Attempt made to force Hall's car off the road into deep ravine. Not injured; did not report accident to police "officially" but did tell two policemen he knew. [1 Sep 68.]

- Jerry Cohen [LA Times 1 May 63]
says Hall, after having denied
knowing Bradley, "apparently now
has retreated" from that position.
In Cohen's paraphrase, Hall says
his memory recently was refreshed
about "events in 1963 and faces
encountered."

Appears before another Bakersfield judge today and is assured his previous testimony will not make him liable to a perjury charge. 30 Apr 68 - In what Jerry Cohen [LA Times

1 May 68] describes as "a

surprising reversal of position,"

says he has information which may
support theory of a conspiracy in
the assassination. Has been
giving serious consideration to
testifying before New Orleans
grand jury. At his own request
appears today before Gov. Reagan's
legal affairs secretary "to
protect myself in the event I do
decide to go to New Orleans."

2? May - Will go to New Orleans to testify before grand jury. Says he addressed a meeting at home of Clinton Wheat, Los Angeles, 1963. Bradly was present and questioned him about his contacts in anti-Castro movement. Bradley denies he has ever met Hall or spoken with him.

5 Mây - Goes to New Orleans; spends
18 hours with Garrison and staff;
no mention of testimony before
grand jury.

28 Apr 68 - Involved in accident on freeway after someone had tampered with steering mounts on his car.

Not injured; did not report accident to police "officially" but did tell two policemen he knew. [National Enquirer, 1 Sep 68.]

24 May - LA Free Press carries Paul
Eberle interview of Hall on his
return from New Orleans (date of
return and date of interview not
given). Hall says Bradley,
trying to get in touch with him
without success, has left
vaguely threatening messages.
Hall gives no dates, but wording
of story suggests this could
have been before he went to
New Orleans. (See item 2 Jan
68, above.)

Describes other incidents, including Bradley having his lawyer call Hall's lawyer to ask if Hall "had remembered Bradley yet." No dates given for any of these incidents with the exception of one "3 to $3\frac{1}{2}$ months ago" involving clippings from "Valley Mail." (See 24 Jan 68, above.)
