'I taught him how to cry in a play by John Drinkwater, called."Bird in Hand," Dr. Albert Upton, his drama coach, recalled. 'He tried conscientiously at rehearsals and he'd get a pretty good lump in his throat and that was all. But on the evenings of the performance, tears ran right out of his eyes. It was beautifully done, those tears!"
