Nixon/Rebozo/Abplanalp meetings (list is probably incomplete):

Rebozo not at San Clemente "this time," during Nixon's  
two-week stay there beginning 12 Jul 74.

Abplanalp - connection between loan from Abplanalp and end  
of antitrust inquiry into Precision Valve Corp.? - See  
entry 18 Oct 73, and Nixon (real estate) file beginning  
9 Jul 73. Memo filed under that date covers chronology from  
11 Jul 69 (first Abplanalp loan to Nixon to buy  
San Clemente) to 2 Feb 71, when antitrust investigation was  
ended.

Rebozo - "Mr. Nixon has been particularly sensitive to the  
charges against Mr. Rebozo."
