"Butterfield/wrote in a memo to Haldeman, '[A. Ernest] Fitzgerald is no doubt a top notch cost expert, but he must be given very low marks in loyalty, and after all, loyalty is the name of the game.' He added, 'We should let him bleed for a while, at least. Any rush to pick him up and put him back on the federal payroll would be tantamount to an admission of earlier wrongdoing on our part.' Butterfield's advice carried the day, and in January 1970 Fitzgerald left the Pentagon. He began in appeals process that was to take years before it yielded even partial results."

Ford, testifying before House Judiciary Subcommittee on his pardon of Nixon, answers questions submitted in two resolutions of inquiry. In answering one question, and reading from a prepared statement, one word in the question is changed, altering its meaning; he answers the altered question and not the one submitted. (Q. Did Alexander Haig refer to or discuss a pardon for Richard M. Nixon ... ? A. ... whether Alexander Haig referred to or discussed a pardon with Richard Nixon ...)
