

- 22 Apr 73 - Dean is expected to testify before Watergate  
Sun grand jury during the coming week. Has asked  
federal prosecutors (no date) for immunity from  
further prosecution, for testimony against  
Haldeman and Ehrlichman.

- H. Chapman Rose meets with Nixon "over the  
Easter weekend" (21-22 Apr) and "reportedly  
advised him that Haldeman and Ehrlichman had to  
go."

- Dean, according to friends, receives phone call  
~~from Nixon~~ in WX from Nixon in Key Biscayne,  
assuring him he still holds his job as counsel.  
ABC News says this is "one of the few times in  
memory" that neither Haldeman nor Ehrlichman  
accompanied Nixon to Florida.

- 26 Apr 73 - Haldeman testifies (8 Nov 73) that he took out  
22 tapes today, and that he thought he returned  
them the same day. Secret Service logs indicate  
they were not returned until 2 May 73.  
(Haldeman resigned 30 Apr 73.) No dates given  
for tapes but one involves Nixon-Dean conversa-  
tion 21 Mar 73, which Haldeman says is the only  
one of the 22 he listened to.

- 27 Apr 73 - Nixon flies to Meridian, Miss., to dedicate new  
Fri military installation, after ten-minute speech  
flies back to WX; Haldeman and Ehrlichman with  
him. very publicly
- Nixon cancels scheduled meeting with economic  
advisers, leaves on short notice tonight for  
Camp David, taking no staff members. "White  
House aides said [he] went to Camp David without  
... Haldeman and ... Ehrlichman," (but this does  
not mean they could not have gone there on their  
own).

- 29 Sep 73 - Nixons fly to Camp David, "leaving all White  
Sat House aides behind."

- Bull testifies 2 Nov 73 that on 29 Sep he

1 Oct that she "accidentally" erased part of

- Nixon goes for two-hour drive with Haig, later  
has dinner at Trader Vic's with young  
Eisenhowers, apparently in very good mood.

Thu weekend, leaving family behind. Accompanied  
by aides, including Buzhardt and apparently

- (A) - Bull says that "at that time it was apparent that two conversations that had been requested were not on the tapes provided to me."

- Haig deputy, Bennett, responsible for WH tape library, says a dozen tapes were taken to Camp David, of which eight were never returned.
