Dear Jim, 6/1/73

Your letter of 5/28 and the enclosures, including notes from both of you, are quite helpful. I appreciate the time you took to refer me. I'm getting much too forgetful. One of the things is in a period I've not read, my NY trip. Krogh on hand-lopping. I think I was also wondering about the date of Colson's grandma-trampling quote. And I think I had these in mind as samples of authoritarian thinking. Recent as it was, I'm not now sure! I don't think this is somatic. I think it is some kind of reaction to our conditions. Whatever the cause, it is real, uncomfortable (when you consider that I once had almost photographic recall) and a real problem in working.

There are some needs to which I must attend at special times. They break everything up very badly and interfere with writing. I spent the morning on some and will have to go for Lil in about two hours. But I began writing at 5 a.m. The prologue, tentatively titled The Past Is Prologue. The kinds of things to which I had to devote time are not conducive to writing, so I'm again cleaning up odds and ends. I haven t read (but I

did clip) the Post.

Howard and NYTimes: he has been able to send little, but my feeling is like yours about any Posts you may have missed (I think none), t'hell eith it. Today I heard from him for the first time in about a week. He enclosed much from 5/25 only. He has been home, in the suburbs, where a paper was delivered. He is now back at school for a summer's work. He has a new address, 3954 Pine St., 19104. As soon as he has gotten the feel of what he has to do he'll let me know when he is coming here. So, don't worry about what I've missed in the Times, thanks.

What bothers is hearing seeing reporting not in the papers, like Agnew and Butz,

Spirit or revenge, betrayal. Ramirez 26 yrs., Cuban born, preine until recently Miami Herald. Was on its 8-man WG team.

Paranica Lane note of 5/27: suggest reading on GL's interpretation in how much now-unscheduled flying he does in helicopters. Agree with you on statistical odds, to which I'd add that helicopters are notoriously less dafe. No word from Dick, which I take it means no encouragement. I'm surprized to find words like fascism being used publicly by Establishmentarians now. If no letter in tomorrow's mail I'll be writing again to feel out on The Informers, the research and some of the writing for which Jim gow has.
