We followed our usual tax-season program this morning and eliminated 1,000 feet of wlking for me. Lil skimmed the Post while I was driving, told me to get an extra paper, and I did (again no Times for today). I got the mail and came home ,intending to go over the paper in the hour of so before I have to leave to keep an appointment. However, in reading the mail so I could think about it, I was again impressed by the accuracy of your perceptions in your 3/9, even when you lacked factual basis. So, to enhance our mutual understanding of what is possible, I respond while it is fresh in mind instead of reading the papers.

Agreed on JG. Aside from the probability of others who may not surface or may at the criminal proceeding or the civil suits whichever comes first - and I do have a couple of candidates - there were also Gurvich and Boxley. The timing you assume happens to be correct. Bethell had not by then defected. But he had by then done something I knew and JG didn't. It came back to me from a peer to whom I had introduced him and who visited him in N.O. So, Bethell, although it is not generally know, was talking at the time in question, even though it was long before he stole the files and turned them over. (Here I digress to remind you that Kirkwood seems to have said that he got the same thing from Boxely, whose name he does not mention. Kirkwood has not responded to my letter.)

Yet there is an element of accident in this. I realize overcoming it would have been no problem, but the fact is that it is only by accident that I met this chick, even looked her up. So, either disagreement or agreement can have meaning. I also think I am in the kind of position you say, so this increases the need for consultation and opinions.
