Je's 3-col Hunts memo w. attached note 9/8/73:

No Lymdon Sheppard losting Alexandris phone book, none for any Sheppard DC yellow pages. No Sheppard on official list Creep, Finance Creep, list employes. Only Shepherd

Katherine, from office Cong. Foley.

Don't remember exact date Hunt turned self in. Planned it for 7/4 weekend according to the one Bennett deposition I have. (Nader won8t let his, which is <u>public</u>, out.) If that gives exact date, I don't recall and it may be in the memo I sent on reading deposition.

Do not recall seeing any newsphoto D. Hunt. Strange. Must be many pix her home.

Believe approx 7/4/72 Hunt did turn up and turn in.

D. Hunt did return from Spain earlier than news stories indicated, again Bennett.

Je's 8/22/73 Nixon San C press conf., tapes.

Confusion deliberate if you read Nixon carefully. This is because, if my recollection is correct, the other tape was one of Dean without "akdeman. The 9/15 one, as I recall, did include periods when Haldeman was not present, despite Nixon's words. What I on looking, listening and then reading regard as the singificant and unintended word in all of this si the "we" in "to be sure that we were absolutely correct in our response." GL seems to have made no response. Context does not suggest he meant "I" by "we" does suggest meaning that he and "aldeman knew what they might have tot live with. What he says, if inadvertently, is that he had to be sure Haldeman knw so they could jibe on everything.

Kalmbach "firing": Think JDW has put together correctly. Form also never stopped representing GL on tax, estate work, so far as I know. Supect they need each other, now even more.

Agnew 9/9/73: These two and much more linked. Very sharp change vis-a-vis GL after their mtg, drisking Jr's troubles. A point missed in Ag's 9/9 speech is his marning to GOPs that they are to be considered Deoms, that only Dems vs WG and GL's dirtiness. The only "embittered critics of this administration and this party...could not discredit us at the polls..." I am not aware of any criticism of GOP by anyone....If all Walsh can say re Brazilians is that they have a "very excellent internal security organization" we know he is Nixonian and anything he says on this suspect. If this story were truthful, there would remain the question of the remarkable coincidence that one of a string of alleged threats was taken seriously just at the time fake ones ve GL were being exploited. And Brazilian "terrorists" ned stimulation to kidnap? Wow- he doesn t even look at TV.

Boggs, 9/9: probaly same guy. Be a natural contact as asst director Protective Research. I was right 'my note) Butterfield was fold. Tray test. Will be sending carbons excerpts Lil is typing.

San Jose file: Will go oevr, select what I want and return, probably after I finish reading the chapter I'm on so Lil can type. Thanks. That clip (those clips) and those on the musical-comedy uniforms just gone. Know I clipped and filed...Glad to get Sat Review on Cubans even if there is nothing new. May hold many reminders and I'm forgetting so much! Another lawyer whose name is now common is Rubin. Lesar also noted this...Read other stories later. Glad to get story Inge Feltrinelli. Spe cooled fast. Right now I'm satisfied I did the honorable thing in refusing to outline because I've already made three shifts sequences and may feel impelled to make more.
