This further response to your 10/4 may be interrupted by someone who is now a half-hour late. He is a stranger who is flying 1000 miles and doesn't know the roads hereabouts, so he may have erred in following the simple directions.

We've almost completed the first half of a concrete project 5 years in getting started. The rich people who built this house chiselled on everyone so the contractors paid them back in various ways costly to us. One example is in not compacting backfilling. We have a partly-disabled mason living without paying any rent at our Hyattstown place. He has been supposed to do the concrete work for 10 these 5 years. He finally corrected the settling of the steps we use most and adding one where we needed it this weekend. He is to come tonight and remove the forms and rub it down with concrete. Next he is supposed to do the same the the "front" steps we rarely use, settled 4" and dangerous for Lil who has a trick knee. Then a walk we do use that is settled on the house side only. The difference is that I've paid enormously more than you and don't have to do any of the work.

Not that it would not have been more pleasant than what you've probably gathered enough of that I have been doing that is neither pleasant in the doing, successful as that has been, nor in the new jeopardy to it by the egocentric nut Bud.
