Raid Has 'Mission Impossible' Ring

The raid against the headquarters of the Democratic National Committee was carried out with all the gadgetry and ingenuity of television's "Mission Impossible" — except for the one incredible omlueter that led to the arrest of a suspect.

When arrested Saturday evening in the back floor of an apartment building in Washington, D.C., the suspect was taken to the Federal Bureau of Investigation (FBI) for questioning.
