Rtd to CIA office & reported to Helms & "Started to check whether this was a fact... I'm not sure whether this was completed Friday afternoon or Monday morning" No chance.

6/26 Monday. call from Dean, who he didn't know. Dean told him to call Eln & check. Eln said "Yes, it is thought to talk to him. He is in charge of the whole matter." Saw Dean that p.m.

"Leads had led to some important people and might lead" to others. Told Dean no poss. CIA involvement in way of no possibility of compromise in mtg w/ (don't do this at mtg w/ mtg.) Dean kept pressing "explaining the options to see whether he could put some of the blame on us"

He told Dean Dean was pressing for a "disorder" (used) would be great. prepared to resign rather than do as asked.

(Check this 6/23 interest in Mexico suits when it became known that the money had gone there)

W in civilian clothes

Conversations 4, 6, 7 of, saying they belong with conversation of 27 rather than 26th (some notes for "next security")

27th Dean told Wm suspects "wouldn't be in my to talk" W said no concern to CIA. "no way" when Dean asked about going back. "It would be a total disaster."

"When we spent covert funds within the US we were required to report that to the Cong. Oversight committees. That seemed to cost him a bit."

28th mtg. Saw Dean alone told Helms mtg with Gray cancelled told W of money from money Sablberg refusing to talk & lost a mission named "Dance"?

Walters, asked for ideas, suggest Cuban play. "Cuban plot" because "every one knows they are under control". W's principal purpose was to direct "Dean from implicating the agency."

He knew Dean was talking it as a suggestion that Dean buy the Cubans & did not want, so release to get CIA off hook.

Walters agreed & told Gray why. They agreed neither could do
anything that would hurt their agencies
Gray told H that the less could not be covered would lead back up
& these people should be fired.

7/13 memo of this mtg with Gray.
7/18 mtg with Gray "to give additional info on one of our people who
had been in touch with my friend in 8/71" & done there.

Apr 7/73 CIA-FBI contact "through our liaison" & through Colby
2/9/73 Dean called Schlemmer, not Walters ("He had gotten my
message loud & clear")

Dean refused to give material CIA had sent to Justice & asked that
it be returned, with a card to remind it had been returned to CIA as
no longer needed. Contents of Gray "all the written material & all of
the photographs" in the Hunt camera.

(He told Sch. the whole story when he came to CIA 1/73)
"CIA material" means everything CIA had given FBI

Saw Dean 2/21/73 14:30, told him CIA it was quite
impossible for us to ask the return of this "material" from FBI
Colby. We made no mention on this visit 5/11/73
when Sch. told him for Sch. also asked all CIA people in
any way connected to prepare an affidavit. We had been in for a while.
Did this on return

WH had to know Montoya with CIA)

Feds on WH "wrong" him for ulterior purposes - not at first
Did not think to ask H what info it could have had on CIA
involvement

Gray knew Bergman & Donberg names last mtg.

"I think the most important thing is to select the right
people for positions of trust"

4) Wucher? Begins on CIA memo 6/20/72 to FSI on WJ personnel
not is "went right to work on this". "This was what, within 3 days?"
Note, this was before WH spoke to CIA before 6/23 phone call & 6/23 mtg.
Note also any checks of flight had to include Mexico, where he had been
How many times did you report "no CIA involvement"? - Many
6/23 ~~mtg~~ mtg with Wucher Dumb "unused" that WH would know of "the
act and operations of the CIA" what Dir & Dep Dir would not.
Can Ehrn & Hille "give out mentions to a CIA agent with out the
Dir & Dep Dir knowing about it?" no.

Talmadge? Had interviewed Therman Johnson & the
7/13/72 memo "The Pres asked him if he had talked to me about the case.
Gray replied that he had. ... The Pres remembered from what
his recommendation was on the matter. ... 'Then I should get rid
of whoever is involved, no matter how high'..."

Note this can mean only that Gray was telling Nixon
a) his own people, high up, were implicated
b) Nixon should fire them.

Gurney? "What the Pres told Haldeman to do" How does G know?
No just many a memo from Nixon. Means G is taking
Haldeman's word with great care on a very dubious matter
Trust his ?'s to ~~statements~~ ^{prev. deficiencies} on Helms, Walters
concludes "But I do wish somebody would have informed the Pres
of the U.S. It would have been very helpful" I had been ^{done}
& this is not the only testimony that is left in the memos.
Erwin? ("mortal injury")
