Questioner familiar with transcript, accurate partial transcript. Hunt said he had to sign paper self for WH interview "of unknown ideology" so he would not be identifiable. "One time interview" speaks during interview sound security of odds & ends of papers do suffer. Why & speed-alteration device. Asked delivery at a safe house" so Hunt would not have to come back to the agency"

Helm's away. Thru after lowest through M. Govt. Wagner. He says only that Hunt "asked for the services of a stenographer" through Hunt chattering to save expenses.

Did not hear of other requests until Technical Services performed. Hunt got tape recorder, camera, brought in another man for when he "talked the T.S. people into giving an alias" and other false papers only known & not worked.

Hunt asked for NY address + NY phone service. (from!) Answering service very inexpensive - that is all Hunt asked. Also asked for + credit get credit cards - 8/31
