Quincy? C/T to Quincy to learn, no direct reporting to Nixon, or work.

There was an official intelligence agencies' operation on "Cables" Had mtgs in one office, with cabinet members there. Could bypass (impersonate) to access only "unauthorized" as access only prohibited by law. But Arthur Helmsman, have there? "I would not consider that paper."

Quincy - Hunt's assignments. Bay Pigs. Others "Hunt for me to recall" Duty question "How often does the CIA help out former employees in the loan of equipment" It was to W.H., not Hunt. Says he didn't understand why he didn't get these things for himself. Quincy says he had some questions. Helms didn't catch it.

Wagner ?'s (He'd watch only members to indicate more ?'s) delicately put, he had been asked to work with the law with Dean's presence, but he did not think to feel Congress. Besides, it had been done "doublely" "It would have been denied" - a more white horse sitting up of CIA
