NEW ORLEANS (AP)-DIST. ATTY. JIM GARRISON HAS OFFICIALLY TERMED THE LATE JACK RUBY, KILLER OF LEE HARVEY OSWALD, A CONSPIRATOR IN THE LATE JACK RUBY, KILLER OF LEE HARVEY OSWALD, A CONSPIRATOR IN THE LATE JACK RUBY, 55, A DALLAS STRIP JOINT OWNER, DIED OF CANCER LAST JAN. 3 WHILE AWAITING TRIAL. HE REPEATEDLY DENIED ANY KNOWLEDGE OF THE ASSASSINATION OF KENNEDY IN DALLAS NOV. 22, 19-63.

THE CLAIM THAT RUBY WAS INVOLVED WAS MADE IN A 93-POINT DOCUMENT FILED MONDAY IN CRIMINAL DISTRICT COURT HERE BY CARRISON, WHO CONTENDS THE CONSPIRACY TO KILL THE PRESIDENT ORIGINATED HERE. THE DOCUMENT WAS IN REPLY TO A MOTION FOR A BILL OF PARTICULARS FILED BY LAWYERS FOR CLAY L. SHAW, 55, WEALTHY RETIRED MANAGING DIRECTOR OF THE INTERNATIONAL TRADE MART HERE. HE IS CHARGED WITH COMSPIRACY TO MURDER THE PRESIDENT.

A HEARING ON THE MOTIONS, AND THE REPLY, WAS SET FOR JUNE 12. THOUGH OUTLINING SOME OF THE ALLEGED ACTS, THE REPLY DENIED THAT THE STATE "IS REQUIRED TO ANSWER IN A BILL OF PARTICULARS ALL OF THE ACTS COMMITTED BY ANY OR ALL OF THE COMSPIRATORS IN FURTHERANCE OF THE CONSPIRACY."

ONE ALLEGED ACT CITED WAS: "CLAY L. SHAW TRAVELING FROM NEW ORLEANS TO BATOON ROUGE IN THE FALL OF 19-63 AND THERE MEETING LEE HARVEY OSWALD AND JACK SUBY A SUM OF MONEY."

IN REFERRING TO RUBY, THE EARLY STATED THAT: "IT IS THE POSITION OF THE STATE OF LOUISIANA THAT THE DEFENDANT ALSO CONSPIRED WITH JACK RUBY, FORMERLY OF DALLAS, TEX., TO KILL PRESIDENT JOHN F. KEMNEDY."

COMSPIRED WITH OSWALD AND THE LATE DAVID W. FERRIE TO KILL KENNEDY. "REASONS KNOWN ONLY TO HENSELF."

GOND THE OSTATION OF THE LATE DAVID W. FERRIE TO KILL KENNEDY. THE OFFICIAL WARREN REPORT SAID OSWALD, 24, SHOT KENNEDY FOR REASONS KNOWN ONLY TO HENSELF."
